An official Steward Council meeting did not take place due to the lack of a quorum. Therefore, no official actions could be taken. These are not official minutes, but a summary of what took place in the two-hour meeting.

Those present met to discuss various issues:

- Hopkins spoke about the Proposition 55 campaign. She will have materials to distribute in October.
- Davis led a discussion about the state of negotiations, as well health care benefits options.
- Wasserbauer read a report of some activities of the union over the past year and made suggestions for future actions.
- Members were urged to write letters to the governor about AB 1690.
- Options of how to get a quorum at Steward Council meetings were discussed: call all members ahead of time to determine who plans to attend, reduce the total number of stewards, restructure the Steward Council, remove/replace stewards who generally don't attend, use remote conference-calling technology.

A petition signed by 7 stewards (Thickpenny, Couch, Mousavi-Shafaei, Lavallo, Allen, Cruz and Hackworth) was submitted to the ACE AFT 6554 Secretary to hold a special Steward Council meeting on **Friday, September 30 at Mission College** (time and location TBD).
